3. **President's Report** Ellen Boyd

Ellen Boyd then invited Daryl Knight, one of the members of our Emergency Evacuation Response Team, to speak to the Members.

Daryl then outlined the evacuation and safety procedures for an emergency. Council do not allow us to write out an evacuation procedure to display on the walls.

There are 4 people involved in the Emergency Evacuation Response Team:-

Ray Cooper - will be responsible for liaising with Fire and Police

Daryl Knight - will be responsible for escape routes
Carol English - will be responsible for Medical issues

Bob Anderson - will be responsible for helping to organize a safe way out.

Exit signs are clearly marked, go to the "little man with the green background" sign.

Do NOT RUN,- WALK, inform Bob or Daryl of those with difficulties with mobility.

Do NOT go into the Courtyard. - You cannot get out, as the gate is kept locked.

There are 3 other exits, Spread out and go through when you can.

FOLLOW THE LITTLE GREEN MAN SIGN.

The Assembly area is on the oval/cricket ground, however if it is not clear, or safe to get there go to the site of the old scout hall next door to the Ajani Hall.

- Keep calm
- Walk out carefully and assist others, who may be very anxious, by taking their arm to keep them calm.

Ellen then thanked Daryl and stated that there had been a lot of work behind the scenes to establish all this information.

Daryl's evacuation procedure is in draft form and requires ratification by the Committee.

4. **Vice President's Report:** Craig Lukeman

Probus South Pacific Limited (PSPL) has increased capitation fees for the coming year from \$7 to \$10 per Member – an increase of 43% which they claim is required to redress a deterioration in their financial performance last year.

Your Committee has decided that given our current strong financial position we will not be charging our Members this additional cost this year. Further increases in fees by PSPL in future years may require our annual fees to be reviewed.

The payment of the capitation fee provides each Member with –

- Comprehensive Insurance: \$20 million Public Liability (plus insurance reserve to cover the excess component for claims against property damage), Personal Injury, up to \$5000 Club Money Cover and \$10 million Association Liability.
- Administrative and advocacy services from PSPL Secretariat.

Spouses and/or approved partners of these Members, Probus Club self-assessed Non Members, voluntary committees, voluntary workers, guest speakers and visitors and all participants in any organised or officially recognised activity of an accredited Probus Club or accredited Probus Association are also covered

The Club also has to pay a \$10 Non Member capitation fee to cover <u>regular</u> Non Member attendees at Club meetings and/or activities. This fee is payable by the Club and not the Non Member.

It is important that we keep a list of all attendees at Club meetings and/or activities so that we maintain Insurance Cover and persons not fitting the above categories should be advised that they are unable to participate in our activities.

5. **Treasurer's report:** Jacob Kerseboom

Jake stated that this would be his last report, as he will not be at the next meeting, he stated that he had enjoyed his time as Treasurer. The end of year financial statement was attended to on 31st January, and it had involved over \$59,000 passing through the treasurer's hands. The Club is financial, and the fees were not going up for this year, as the \$3 extra charged by PSPL could be met by Club funds. All reports, functions and activities were recorded.
