MINUTES OF NOVEMBER CLUB MEETING PROBUS CLUB OF TEMPLESTOWE VALLEY Inc.

Held at Ajani Centre, 284 Thompsons Road Lower Templestowe, 3107 On Monday 10th November 2014

1. **Welcome:** President, Craig Lukeman opened the meeting at 9.45am and welcomed members and the 5 guests to the meeting.

2. Confirmation of Minutes

3. **President's Report**

The Committee has been following the activities of what is called the PSPL Reform Group for the past couple of years and want to inform you of the current situation.

This Group was set up by a number of Probians who are dissatisfied with the way Probus South Pacific Limited (PSPL) has been performing and who have been seeking a variety of reforms to the governance and structure of PSPL. PSPL was originally set up as a service centre to provide assistance to Probus Clubs in Australia, New Zealand and the Philippines. However over the years it has moved into commercial ventures such as selling travel insurance and the Active Retirees magazine.

This has led to profits being generated and wherever there is a sniff of profit the Australian Tax Office inevitably takes an interest!

You may recall that PSPL disingenuously attempted to avoid tax liability by trying to amend the aims and objects of Probus to read "to help members of the community by relieving isolation and loneliness associated with ageing etc." and replacing the original aims of promoting Fun, Fellowship and Friendship. Clubs were asked to endorse this change but resoundingly rejected it and as a result PSPL lost its tax exemption status and became liable for tax on past earnings since 2010.

An allowance of \$230,000 was made for the tax liability for the years 2010-2013 but the recently published Annual Report for March 2014 shows that this was insufficient and that an additional provision of \$127,807 was necessary. Various other expenses were also incurred with the result that PSPL revealed a net loss after tax of \$421,634 for the year ending 31 March 2014 and that as of that date, current liabilities exceeded current assets by \$402,490. The accounts note that:

"These results give rise to some uncertainty which may cast significant doubt over the Company's ability to continue as a going concern."

It is also noted that total assets are \$3,023,429 exceeding total liabilities by \$683,924. The main asset is the lavish offices PSPL has obtained through entering into significant debt.

PSPL is proposing to further increase capitation fees in order to reduce losses and to undertake some unannounced cost reductions in their operations.

An increasing number of Clubs in New Zealand have opted out of PSPL in recent times and this will reduce PSPL capitation fee income during this current year.

Questions and explanations from the floor regarding the President's report.

PSPL = Probus South Pacific Limited

1. Kerry McInerney asked if Rotary have any input into PSPL these days, as he knew that Rotary set up Probus in the South Pacific region and wondered if they were still involved.

Answer. Craig Lukeman (President) replied that Rotary is still involved

2. John Mugridge asked why Members had not been informed about PSPL

Answer Ellen Boyd (President 2013) replied that there has been nothing to report to the Members, as neither the Rotary representative for our area, Robert Renshaw nor PSPL have replied to any or our requests for explanations or clarification of matters.

- 3. Bob Anderson (President 2012) stated that the Travel Insurance had been \$200,000 in the black, but had now failed, and was now in debt. Travel insurance through PSPL was more expensive than many other insurers available to Members. PSPL needed to get back to basics.
- 4. Phil Mithen asked what was the situation with the Probus Clubs that had opted out of PSPL in New Zealand. Answer. Craig Lukeman said that they had set up Probus New Zealand and were still part of Rotary.

5. Guy Tuddenham asked how much the capitation would be increased and what were the Probian number s involved with PSPL.

Answer. As it appears that a PSPL representative was unable to answer this question at a recent(31.10.2014) meeting for the Manningham Probus Interest Group, the Committee was unable to answer Guy's question.

Guy Tuddenham asked that on the Agenda for January 2015 Club Meeting it be put "to discuss PSPL and the number of members that are involved with Probus" Request Actioned by Libby Jones

Some clubs have performed evacuation procedures and this was seen to be a necessary action.
