INTRODUCTION

This is the 18th Annual Report of the Probus Club of Templestowe Valley (Combined) Inc.

The Probus movement had its genesis in two ancestors – both in the UK and both established by Rotary Clubs. The first was formed in 1965 and was known as the Campus Club – its name was derived from the area of the town in which it was conceived – the Campus. The second was formed by the Rotary Club of Caterham in 1966 and was named the Probus Club for the “PRO” in professional and the “BUS” in business and which also made up the Latin word from which “PROBITY” is derived. Both were formed to meet the need for companionship of their peers and mental stimulation for retired business and professional men.

Today there are Clubs for male, female and combined gender.

The first Club in Rotary’s South Pacific area was the Probus Club of Kapiti Coast, New Zealand in 1974. The first Club in Australia was the Probus Club of Hunter’s Hill, NSW in 1976.

Today Probus is a world-wide movement in 25 countries.

Probus South Pacific Limited

What is now known as PSPL was formed in 1981 in Sydney when five Rotarians, all of whom had been involved in the formation of Probus Clubs came together to share their experiences. They recommended the provision of an information service to Rotary Clubs throughout the region. The result was the Probus Information Centre.

At the time of formation it was noted that “It was important however that the Centre would not be a controlling body, or Probus Head Office, but rather a service or information centre.”

In 2010 the Board of Probus Centre – South Pacific created a new organisation to replace the Centre.

The new organisation is a company limited by guarantee, and Probus South Pacific Ltd. (PSPL) is formed under NSW law. It is a commercial organisation but simultaneously takes for itself the right to control all non-profit Probus Clubs and organisational structures in the South Pacific.

Mission

PSPL is dedicated to promoting the development of friendship, fellowship and the advancement of intellectual interests for active retirees through Probus Clubs in the South Pacific area.

Vision

The vision of PSPL is to co-ordinate the growth, development and ongoing support for Probus Clubs, as the most widely recognised organisation for active retirees, in fostering the true spirit of Probus – friendship, fellowship and fun.

Manningham Probus Interest Group

There are over 20 Clubs in the Municipality of Manningham and these have formed the Manningham Probus Interest Group. Two delegates from each of the Manningham Clubs are invited to attend twice yearly meetings of the Group (usually held in March and October) where items of mutual interest are discussed and information on speakers and outings exchanged.

An Information Day is also organised in April for any interested Members. This day can be a valuable resource for Committee Members.

Probus Club of Templestowe Valley (Combined) Inc.

Currently we have 150 Club Members, including two Life Members, Kerry McInerney and Doug Hayne. It is 18 years since our Club had its inaugural meeting on June 12, 2003, under the guidance of Manningham Rotarians, the late Ken Murray and Max Didier, when 62 Foundation Members signed up in the hall at the Ted Ajani Reserve.

The Club was incorporated in 2004. The Secretary holds the official position of Public Officer. By being incorporated, any litigation needs to be directed to the incorporated body and cannot be directed to individual members.

The Club meetings are held on the second Monday of every month throughout the year and commence at 9.45 am in the Ajani Centre, 284 Thompsons Road, Lower Templestowe, 3107.

Club Insurance

PSPL provides universal insurance cover for Members and third parties attending official and approved Club events. Each Club is levied an annual fee to cover this insurance. The PSPL charges an annual fee per member.

COMMITTEE MEMBERS' ANNUAL REPORTS 2020 - 2021

PRESIDENT'S ANNUAL REPORT

I was looking forward to my year as President during my role as Vice President not knowing of course what was to come. The AGM and Club meeting that followed on 9th March 2020 would be the last Club meeting for ten months.

The COVID19 virus was in the news during February along with bushfires and drought. Little was it known that very soon profound changes to our freedom and way of life would be introduced to stop the spread. A pandemic was declared by the World Health Organisation. By the end of March all Club meetings and activities had to be suspended until further notice. In early June restrictions were eased and a few outdoor activities resumed with a maximum of ten people. But it was short-lived and severe "stay at home" measures were reimposed due to a second wave of infections in Melbourne's north and northwest. A night curfew was even introduced and a 5km limit set for travel from home.

In September, a phone "buddy" system was organised by our Welfare Officer to make contact with our single members. And the Management Committee held its first meeting since June online face-to-face via an app called "Zoom" at no cost. The Meeting in October was also via Zoom. It was at this meeting that it was decided to waive fees for next year for current members and convey this by sending out a Christmas card. The November one was held outdoors, due to indoor gathering restrictions, at Ruffey Lake Park. Remaining ones held at Committee members' homes as is usual.

In early December I was pleased to learn that the Hall was to reopen on 11th January 2021, which coincided with our Club meeting timetable. This followed further easing of restrictions, in particular the reduction of the social gathering limit from one person per 4sqm to 2sqm for indoor gatherings.

So, 2021 heralded a COVID "normal" environment and almost a resumption of life as we know it. The virus is still around, invariably from returning travellers to Australia, but systems are in place to curtail it.

Management Committee members have done a wonderful job in attending to matters in a difficult setting for the benefit of Club members. I thank them very much for their contribution.

SECRETARY'S ANNUAL REPORT

In the first two weeks after the AGM, I was able to complete the Annual Forms for PSPL regarding Capitation and Membership, provide Manningham Probus Interest Group with new office bearers, notify Manningham City Council of new addresses for the Liaison Officer and Treasurer and complete the Annual Form for the Department of Consumer Affairs. And then came our first lockdown. Your Committee decided to continue with the newsletter to stay in touch with members, offering support where needed plus a few jokes along the way.

The Committee didn't have another meeting until June when there was a small window where we could also catch up with friends and family. Of course, this wasn't to last and we spent the next four months in a strict lockdown with a curfew.

In September, the Committee held its first Zoom meeting followed by another one in October. Most Activity Groups had, by this time, commenced Zoom meetings which were enjoyed by all members involved including some who enjoyed wine and cheese Zoom get togethers.

This worked really well with everyone being registered. Even if their phone wasn't compatible, another member added the details on their phone. In February, we welcomed 110 members back to the Club meeting. Thank you to Pat Marsh, Wayne Eames and Irene Baird for your help with QR codes and Laurine Eames and Keith Marsh for helping at the desk.

Whilst the last twelve months have been challenging, I have been kept busy and occupied as well as developing new skills and friendships within the Club. I am enjoying the position and wish to thank Anne Lukeman for all her support especially with the Agendas and Minutes.

TREASURER'S ANNUAL REPORT

My first year as Treasurer of TVPC started out well with Members paying for Activities and Annual Fees as usual. However, it rapidly deteriorated as COVID-19 hit our shores and all Activities and Monthly Meetings were cancelled and the Activities money had to be refunded. We only paid \$12 per member Capitation Fee to PSPL this year instead of the usual \$15 and the Committee decided to waive payment of the Annual Fees for the coming year (2021/22).

I applied for two grants on behalf of the Craft Group for their continuing work making "Post Operation Recovery Products" for donation to several local hospitals to supply to their patients in need. Both grants were awarded.

Firstly, a Stockland Care Grant of \$1,000 was received and used to buy raw materials. Then the Manningham City Council "COVID-19 Grass Roots Recovery Grant" for \$3,600 was received and has been partially spent; the Craft Group has until 30th September 2021 to spend the remainder. TVPC is very appreciative of this generous support and there will be an article in the February "Manningham Matters" to this effect. A third Craft Group Grant for \$4,000 from the Government Community Grants Hub, which had been carried over from the previous financial year, was discharged during the year. June Duncan made a very generous donation to the Craft Group of just over \$1,000 which had been raised at Hayville Retirement Community.

In the past, the Treasurer's Monthly Report has been presented verbally at the Monthly Meetings but as there have been none of these, I have been inserting my Report into the Monthly Newsletter since September.

Many thanks to all of you for your support in my new role and particularly to Bob Anderson for holding my hand and keeping me on the straight and narrow!

Notes to Financial Statements for the year ended 31st January 2021

As a result of the COVID-19 pandemic:

- * The Club was only able to meet in February and March 2020 and in January 2021. All activities ceased during the lockdown period and money that had already been paid for upcoming Activities was refunded to members.
- * PSPL refunded \$3 per member of the \$15 Annual Capitation Fee and, with no Monthly Hall Hire, the Committee decided to waive Annual Fees for the year 2021/2022.
- * Westpac Bank reduced the interest paid on our cheque account to 0.0%.

The Craft Group continued to function during the lockdown period and we were awarded two new grants - a Stockland Care Grant for \$1,000 and a Manningham City Council COVID-19 Grass Roots Recovery Grant for \$3,600.
